## Protect Yourself from possible Data Breaches and Identity Theft

Here is what you can expect from your Credit Union:

We're actively monitoring your account 24/7 and will alert you anytime we see suspicious activity. **Be sure to keep your contact information up to date.**

Here is what member's should consider doing:

Visit: <https://www.equifaxsecurity2017.com> to see if your information has been put at risk

**Check your credit reports--FOR FREE--** by visiting [annualcreditreport.com](http://annualcreditreport.com), check accounts or credit activity that you do not recognize which may indicate identity theft

Visit [IdentityTheft.gov](http://IdentityTheft.gov) to find out what to do if you think you are a victim

Place a **credit freeze** on your files, making it harder for someone to open a new account with your personal information

*-Keep in mind—a credit freeze won't prevent a thief from making charges to your existing accounts*

Place a **fraud alert** on your file, if you decide against a credit freeze

*-A fraud alert warns creditors that you may be an identity theft victim and that they should verify if anyone seeking credit in your name really is you*

**Monitor your existing** credit card and bank accounts closely for suspicious charges

**File your taxes** as soon as you have the tax information

*-Respond right away if you receive a letter from the IRS*

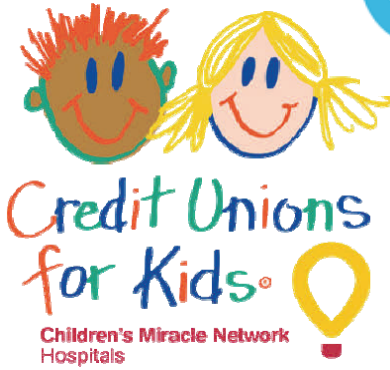
